*Object: Emir Kusturica's contribution to the "All the invisible children" production*

Dear Ms. Veneman,  
Dear Ms. Sheeran,  
Dear Ms. Belloni,

We are writing to you to express our grave concern regarding the support and promotion, by your organisations, of the short-movie "Blue Gypsy" by the Yugoslav filmmaker Emir Kusturica in the context of a campaign to raise awareness on children's rights.

Just as in his previous films, Kusturica plays on the idea of lazy and irresponsible Roma parents who force their children into stealing. While we do not entirely deny the existence of such a phenomenon and the need to intervene, we do however disagree with the fact that it has come to dominate the public representation and discourse about Roma, which is unfortunately also a consequence of the awareness raising campaigns run by international organisations and NGOs.

While such an approach may be powerful to attract public attention and funding, it has the detrimental side-effect that it diverts attention from the root causes, i.e., the abject poverty and marginalisation of Roma families, to expose one of its possible consequences. It also promotes the idea that Roma themselves are the mainly responsible for their problems, and that the interests and well-being of the children may eventually be better served by removing them from their families, which seems also to be the conclusion of Kusturica's short movie.

Among all those children whose rights are abused, Roma children occupy a sadly prominent position, which has also been well documented by numerous reports of organisations such as UNICEF. The deprivation of their families may actually in itself be considered as a form of abuse, since the right to education, health care, and adequate housing, are guaranteed by international human rights instruments.

We would therefore have appreciated if the film had shed light on living conditions of Roma children instead of perpetuating stereotypes which may again be used to justify their further discrimination, thereby perpetuating the vicious circle of prejudice and marginalisation.

While we do not advocate for a removal of the film from the entire production, we recommend that it should be followed by a public discussion, especially if it is presented in the context of the celebration of the sixtieth anniversary of the declaration of the rights of the child. Our organisations stand ready to participate in such a debate.

We would furthermore like recommend that future campaigns on issues affecting the Roma communities should be prepared in cooperation with Roma civil society organisations in order to avoid that they further contribute to fostering racist views.

***Objet: La contribution d'Emir Kusturica à la production « All the invisible children »***

Mesdames,

Nous vous écrivons pour exprimer notre vive préoccupation concernant le soutien et la promotion, par vos organisations, du court-métrage du cinéaste yougoslave Emir Kusturica « Blue Gypsy » dans le cadre d'une campagne de sensibilisation sur les droits de l'enfant.

Tout comme dans ses précédents films, Emir Kusturica y développe l'idée que des parents roms, paresseux et irresponsables, poussent leurs enfants au vol. Bien que nous ne voudrions pas complètement nier l'existence de ce phénomène et la nécessité d'agir, nous refusons cependant à ce qu'il ne vienne à dominer la représentation et le discours publique sur les Roms, ce qui est, malheureusement, aussi une conséquence des campagnes de sensibilisation menées par les organisations internationales et les ONGs.

Si cette approche est certainement très efficace pour attirer l'attention publique et des financements, elle contribue aussi à détourner l'attention des causes premières, c'est-à-dire, la pauvreté et la marginalisation, pour se concentrer sur les conséquences possibles. En même temps, elle contribue à renforcer l'idée selon laquelle les Roms sont les principaux responsables de leurs problèmes, et que les intérêts et le bien-être des enfants seraient peut-être mieux préservés en les séparant de leur famille, ce qui semble également être la conclusion du court-métrage de Kusturica.

Parmi tous ces enfants dont les droits sont bafoués, les enfants roms occupent malheureusement un des premiers rangs, ce qui a également été démontré par de nombreux les rapports préparés par des organisations comme l'UNICEF. La privation subie par leur famille doit elle-même être

considérée comme une forme d'abus, puisque les droits à l'éducation, aux soins de santé et un logement adéquat sont garantis par les instruments internationaux de protection des droits de l'Homme.

Voilà pourquoi nous aurions aimé que le film ait pu faire la lumière sur les conditions de vie des enfants roms au lieu de perpétuer des stéréotypes qui peuvent ensuite être utilisés comme motifs pour justifier la poursuite de la discrimination à leur égard, contribuant ainsi à éterniser le cercle vicieux de préjugés et marginalisation.

Si nous ne préconisons pas la suppression du court-métrage de l'entièreté du film, nous demandons cependant que sa présentation soit suivie par un débat public, surtout, si elle doit avoir lieu dans le cadre de la célébration du soixantième anniversaire de la déclaration des droits de l'enfant. Nos organisations sont prêtes à participer à un tel débat.

Nous voudrions également recommander que de futures campagnes sur des sujets qui touchent les communautés roms soient préparées en coopération avec les associations de la société civile rom, afin d'éviter qu'elles ne contribuent encore à renforcer des préjugés racistes.
